

1. Introduction to CURS

The Centre for China Urban and Regional Studies (CURS or the Centre), currently housed at the Department of Geography of Hong Kong Baptist University (HKBU or the University), was established on 1 July 2001. CURS was founded with a major donation from Heung To Educational Fund secured by Professor C F Ng, President and Vice Chancellor of the University.

CURS aims at conducting high quality research and cultivating academic exchange on China's urban and regional developmental issues. Research fellows of CURS include faculty members of the University who come from a variety of disciplinary backgrounds but who share a common interest in urban and regional research on China. It is the objective of CURS to enhance the University's status as an academic hub for the study of China's cities and regions.

Research conducted by CURS research fellows covers a wide range of intellectual and policy-oriented domains: regional disparities, housing privatization and housing market segmentation, transportation and land use, environmental management and sustainable development, social problems and social service provision, cultural landscape, inter-regional and rural-urban migration, social stratification, quality of life, and urban modelling, including the application of geographic information systems and remote sensing techniques in the study of urban and regional change. Since founding, the Centre Director and his research team at CURS have pioneered micro-analysis of urban housing and residential change in China in collaboration with research institutions in Mainland China and elsewhere, such as the Centre for Urban and Regional Studies at Sun Yat-sen University, Guangzhou, the Xinjiang Institute of Geography and Ecology, the Urban China Research Network of the University at Albany, New York, the Urban China Research International Network of Cardiff University, Wales, and the Urban and Regional Research Centre of the University of Utrecht, the Netherlands.

2. Research Activities Conducted

2.1.1 Conference on China's Thirty Year of Reform, 16-18 December, 2008, Hanoi

A three-day Conference "China's "Thirty Year of Reform: Accomplishments and Experiences (中國改革開放 30 年的成就與經驗)", jointly organised by the Centre for China Urban and Regional Studies (CURS), Hong Kong Baptist University; Hong Kong Society of Asia and Pacific Twenty-One and the Institute of China Studies, Vietnamese Academy of Social Sciences; was successfully held on 16-18 December 2008, in Hanoi, Vietnam. 2.1.2 Workshop on "Enclave Urbanism as Problem or Solution: European and Asian Perspectives", 10-12 June 2009, Utrecht, the Netherlands





CURS and the Urban and Regional Research Centre of Utrecht University jointly organized a workshop on "Enclave Urbanism as Problem or Solution: European and Asian Perspectives" on 10-12 June 2009 at Utrecht, the Netherlands. 3.1.1 Transformation of virtuality: Use of internet in reengaging youth in social

withdrawal (FRG/07-08//II-16)

Brief Introduction

There are two entirely different perspectives in deconstructing the phenomenon of social

withdrawal of young people, the first of which is to take youth's indulging in the internet

world and online games in particular, as the fundamental cause of social withdrawal; the

second is to take the internet as a venue for virtual interaction and relationship building

and as a means to overcome the problem of social withdrawal. Informed by the latter

perspective, the aims of this proposed study are to: 1) compare the tactics adopted by

professionals and volunteers/laymen in approaching and interacting with social

withdrawals in the internet world; 2) examine the different means employed to transform

virtual or internet interaction with targeted youth into face-to-face contacts and their

eventual participation in the real world; and finally 3) study the characteristics of two

different profiles of cases established by social work professionals and volunteers/laymen

respectively. Regarding research methodology, young people who have overcome social

withdrawal or who are in the process of reengagement will be interviewed, and

professionals and volunteers/laymen working with this vulnerable group interested in the

internet world will be separately interviewed.

3.1.2 Young people entrapped in social withdrawal: Disengagement versus

reengagement in the light of social exclusion (GRF/07-08/244707)

Brief Introduction

The under-researched phenomenon of youth-at-risk who are socially withdrawn from

their peers and the community, and disengaged from school, training or work has recently

become a growing concern to the public in general and to helping professionals in

particular. Youth's reaction to life events or crisis in the form of social withdrawal or

disengagement is arguably a social process, which is shaped, amongst other factors, by a

set of social norms regarding so-called normal pathway of development, and equally

important by the disadvantaged socioeconomic circumstances in the form of social

exclusion. With the use of surveys, case studies and interviews, the research study will

inquire into four interrelated areas, namely, a) the prevalence of social withdrawal among

young people aged 12-24; b) the nature, extent and social processes of social withdrawal

and disengagement on relational, cultural and institutional levels; c) the patterns and

processes of activities pursued by young people and the responses and actions taken by

the significant others at times of withdrawal and reengagement respectively; and finally d)

the tactics and strategies employed by social workers in re-engaging young people, and

the challenges confronted. Both the subjective and structural dimensions of

disengagement and the informality and formality of reengagement attempts and measures

are deemed important if the phenomenon is to be critically examined and the needs of

this vulnerable youth group satisfied.

3.1.3 Exploring the Social Networks of Residents in Tin Shui Wai

Brief Introduction

The proposed research adopts the social network approach to examining the personal well-being and community attachment of Tin Shui Wai residents. It addresses four specific issues: (1) What is the structure and composition of social networks of residents in Tin Shui Wai? (2) What are the individual and contextual factors that may influence the formation of social networks? (3) What kinds of resources do the residents get from their social networks? (4) What are the impacts of social networks on the residents' well-being and community attachment? Semi-structured in-depth interviews were conducted to collect information from 21 residents and eight community organizers. Tin Shui Wai North was found to be a loosely-integrated community. The respondents indicated superficial relations with neighbors, a low level of community trust, a strong sense of self-protection, and passive community participation. The short duration of residence and complex population mix were reported as major barriers against building close social ties in the community.

The project aims to conduct literature review and empirical groundwork for a collaborative research project with Nanjing University on gender and the family in contemporary China. The systematic review of research literature will cover five areas, including (1) Gender norms and attitudes in China, (2) Gender relations in the family, (3) Intergenerational relations, (4) Gender inequality over the life course, and (5) Forms of intimate relationships. Preliminary data will be collected in Nanjing on these five areas.

3.1.5 Urban Restructuring and Relocation of Housing and Jobs: Implications for Access

to Employment Opportunities and Spatial Mismatch in Chinese Cities

Brief Introduction

Chinese cities have undergone profound transformation in recent years. To capitalize on

rising land prices, many work units have relocated the production plants to the suburbs,

leaving behind the workers in dilapidated housing in former work-unit compounds. At the

same time, a large number of inner-city dwellers has been relocated to outlying suburbs

consequent upon redevelopment projects. Complicating the matter are the millions of

migrants seeking their fortune in the city who are trapped in the "villages in the city". The

almost perfect match between job and housing distributions characterising pre-reform

China is being rapidly torn apart. The need for commuting is on the rise. Especially

caught are the low-income manual workers and the migrants. To them the cost of

commuting is exorbitant, both money-wise and time-wise. While rapid economic growth

may have generated ample new jobs, for a substantial segment of the population access to

jobs has become difficult. A spatial mismatch of job and housing (Kain, 1968; Houston,

2005) could have emerged. Based on large-scale surveys conducted in Guangzhou,

Beijing and Shanghai, this project examines the extent to which the spatial mismatch

hypothesis holds in the Chinese case and how this may have exacerbated urban

unemployment and the problem of rising income inequalities.

Experiences in Urban China: A Comparative Study of Guangzhou and Shanghai

Brief Introduction

The transition from a centrally planned to a socialist market economy in China has engendered incessant spatial restructuring and produced a plethora of housing and community types in urban China. First there are the pre-1949 tenements and courtyard housing in the urban core. Massive redevelopments in recent years have uprooted tens of thousands of residents and impinged heavily on these communities. Second there are the danwei compounds of the socialist planning period located outside the core. Housing sold to sitting tenants under the reform has since been given full property rights and allowed to enter the market. The resultant inflow of unrelated inhabitants is now undermining the homogeneity and integrity of many danwei compounds. Third, there are the commodity housing estates in redeveloped inner-city neighbourhoods and newly developed suburbs populated by China's rising middle class. The new owner-occupiers are eager and relatively well resourced to defend their rights so as to maintain the value of their properties. Finally, there are the urban villages on former urban-rural fringes with concentrations of rural migrants.

A distinguishing feature of Chinese cities is the presence of boundaries and gates. They delineated the danwei compounds before. They are also features of the new commodity housing estates. But the meaning of boundaries and gates could be quite different for the former worker-residents and for the new owner-occupiers. Surely, there are also communities which are more loosely defined physically; yet residents' committees have been empowered to perform community building functions in such communities.

Using data from household survey conducted in Guangzhou and Shanghai in 2005 and 2006-7, together with data from supplementary fieldworks as well as from census and other sources, the proposed study attempt to analyse the interrelationship between community formation and neighbourly relations, on the one hand, and residential experiences, on the other, and examines how such relationships are conditioned by the changing built environment of the residence in light of China's unprecedented urban and economic and social transformation. Special attention is given to the effects of boundaries and gates. Both quantitative and qualitative works are needed to unravel the

richness and diversity of behavioural responses of the residents in adjusting to and making the best out of the changes in structural or institutional forces and environmental features. The quantitative analysis will involve structural equation estimations with built-in feedback loops. The more qualitative works require extensive field observations and in-depth interviews with different stakeholders.

Impacts by the Expansion of Irrigated Farmland Expansion in Aridzone of China

Brief Introduction

Land cover change is one of the most sensitive indicators that echo the interactions between human activities and natural environment. In arid environment, the rapid expansion of cultivated land in the marginal region has destroyed native rangeland vegetation cover and caused intensive competition on limited water resource. The proposed research is to investigate the environmental impacts due to rapid expansion of cultivated land in the marginal area of arid zone of western China. Multi-temporal satellite imagery will be used to create a spatio-temporal image of changing farmland since early 1990's when the national and local governments' policy stimulated considerable investment on irrigated agriculture in the fringe area of deserts. Landscape metric that is commonly employed in ecological studies will be applied to this spatio-temporal image and change trajectory of farmland will be established. It is expected that the spatio-temporal pattern of the farmland change can be revealed by the interpretation of the landscape metric so that areas and sequence of farmland growth can be identified. The goal of the study is to develop a practical methodology for assessing the growth limit under constrains of water resource, environmental vulnerability and sustainability of the growth.



The conference covers a wide variety of topics, including the interrelation between transportation and geography, transportation, land use and built environment, etc. Up to date, about 100 full papers and 160 abstracts authored by academics and professionals from all over the world have been received. The conference are expected to foster excellence in investigation of transportation and related issues, stimulate professional interchange, and provide a forum for exchanging ideas on transportation developments.

5.2 Publication of the book 'Awakening of the Dragon: China's 30 Years of Reform, the Return of Hong Kong and Macao, and New Development Paradigms in East Asia' 《巨龍的甦醒: 中國改革開放三十年、港澳回歸、與東亞發展新範式》



As a continuing effort for the 12th International Symposium on Coordination of Chinese

Economic Systems held in December 2008 at Hanoi, the proceedings are being edited for publication. Professor Si-ming Li of CURS chairs the editorial committee. Other committee members include Professor Chih-lien Huang of the University of Macau, Professor Donglin Chen of the Institute for Contemporary China Studies, the Chinese Academy of Social Science, and Professor Phung Thi Hui of the Centre for China Studies, the Vietnamese Academy of Social Science. The book will comprise 29 chapters written by academics and media commentators from mainland China, Hong Kong, Macau, Vietnam, and Japan. The topics include the experience of China's reform, the relationship between China and her neighbouring countries especially ASEAN members, future developments in the early 21st century, and the like. A distinguishing feature of the book is to explore the compatibility of China's experience in Vietnam. According to the publisher, The Publications Centre of the University of Macau, the book will be in print in December 2009. (see Appendix 2)

5.3 Journal special issues on enclave urbanism

Subsequent to the holding of the workshop on "Enclave Urbanism as a Problem or Solution: European and Asian Experience" at Utrecht, the Netherlands in June 2009, the organising committee comprising Professor Ronald van Kempen and Dr Bart Wissink of the University of Utrecht, Dr Yiping Fang of Erasmus University, and Professor Si-ming Li of CURS is currently working on two journal special issues based on papers presented in the workshop. The first is an issue in *Urban Geography* entitled "Living in Enclave Chinese Cities". The second is a special issue in *Geoforum* focussing on the experience of European and Asian cities other than cities in China. The four members of the organising committee now acts the guest editors of these two special journal issues.

5.4 Planned Conference on China Urban Development

CURS and the Centre of Urban Studies and Urban Planning of the University of Hong Kong are currently planning to hold a major conference on urban development in China in late 2010 or early 2011. This conference, which will mark the 10th Anniversary of the Centre, will further ascertain the position of CURS as a major centre of urban and regional research on China.

6. Overall Self Evaluations

Over the years the CURS occasional paper series has served a useful channel for the CURS research fellows and other scholars working on China urban and regional studies to disseminate their latest research findings in the quickest manner possible so as to facilitate academic exchange. In addition, CURS has actively involved in a variety of collaborative works with research institutes and scholars in Hong Kong, mainland China, and overseas. In the academic year under review, CURS joint force with the Hong Kong Society of Asia and Pacific Twenty One and the Vietnamese Academy of Social Sciences to hold the "12th International Symposium on Coordination of Chinese Economic Systems" at Hanoi in December 2008. CURS also joint force with the Centre for Urban and Regional Studies of the University of Utrecht, the Netherlands, to hold the "Workshop on Enclave Urbanism as Problem or Solution: European and Asian Perspectives" in June 2009.

These conferences, which were attended by leading scholars as well as by aspiring younger academics, have formed the basis of a subsequent book project, the Awakening of the Dragon, which will be in print in the latter part of 2009, and special issues in two of the most renowned international journals in urban studies, namely, Urban Geography and Geoforum. Currently, CURS is joining force with the Hong Kong Institute of Transportation Studies to hold the conference "Transportation and Geography", which will be held in December 2009. CURS is also collaborating with the Advanced Institute of Contemporary China Studies of Hong Kong Baptist University to undertake consultancy study for the Planning Department of the Hong Kong SAR Government on cross border transport development between Hong Kong and the mainland.

All these efforts have helped to establish CURS's position as a leading centre of China urban and regional research, and enhanced its function as a platform facilitating academic collaboration on the study of China's cities and regions. Irrespective of its size, CURS is on way to make substantial impacts in the international academic arena and beyond.

Occasional Paper No. 82 (July 2008)

天水圍:怎一個「虧」字了得?

文章從歷史地理的維度入手,抽絲剝繭,解開天水圍發展的疑團,論證「規劃失誤」 論的貧乏。文章把天水圍發展放在特定時空演化的土地發展體制中去分析,由一個 選定在天水圍土地上投機的地產項目說起,港英政府爲了減低由地產市道不景而導 致此體制崩潰的可能性,不惜動用公帑,挽救這個項目,計劃在天水圍建設起一個 新市鎮。新市鎮的規劃建設,是先有私人屋苑、後有公共屋邨,就這樣,天水圍強 調以交換價值爲主的空間,而輕視使用價值的空間。公屋居民苦於缺乏就業機會、 公共設施、對外交通等絕對空間和相對空間,對比區內設備比較齊全的私人屋苑居 民、又無法與區內原居民聯繫、繼而關聯舊日在市區(或大陸)的生活,從而普遍 滋生强烈的無奈及無助,導致種種悲情事件發生。因此,輿論把問題簡化爲「規劃 失誤」,是徹頭徹尾的去政治化行動。如要改變現況,只有把天水圍發展問題從「規 劃失誤」的非政治化來一個再政治化,放回到土地發展體制的層面來探究。

Mortgage Loan as a Means of Home Finance in Urban China: A Comparative Study of Guangzhou and Shanghai

Si-ming Li, Quan Hou and Zheng Yi

This paper examines the use of mortgage loan to finance home purchase in transitional

China, using data derived from household conducted in Guangzhou in 2005 and in

Shanghai in 2006-07. In both cities demographic and socioeconomic attributes on the

whole have little effects on the decision of whether or not to employ mortgage loan, or on

how much to borrow in relation to the value of the property, given that mortgage loan is

employed. Given that mortgage finance is a very new development in China, the lack of

association is not surprising. It takes time for individual homeowners to fully appreciate

the pros and cons of employing mortgage finance, and for the banks to assess the

prospective borrowers' mortgage needs and repayment abilities. In the mean time, the

majority of homebuyers in urban China continue to rely heavily on personal savings and

parental contributions to finance home purchase.

security mechanisms and performance evaluations. Implications of these findings and
